Listed reinforcement only package includes areas for 2-horizontal bars on back wall, a single horizontal bar on head end wall, a single horizontal bar on control wall, and a single vertical bar at entry on control wall.

Standards Certification:

The bathtub compartment listed is manufactured in compliance with ANSI Z124 Standards, and certified through an ongoing, independent quality assurance and testing program.

The factory-applied reinforcement package is installed in compliance with HUD-FHA Fair Housing Act Design Manual, and certified through an independent review program.

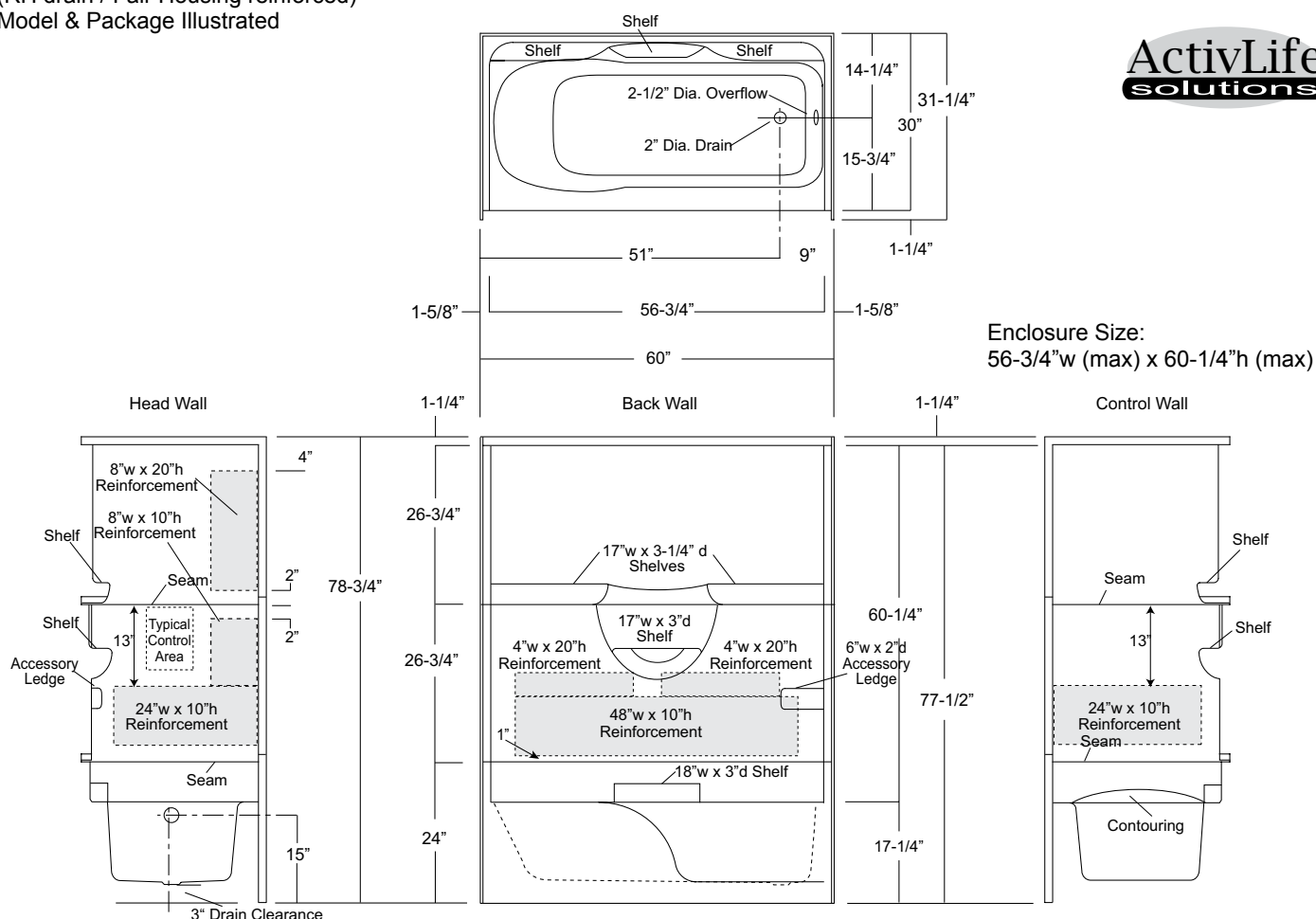

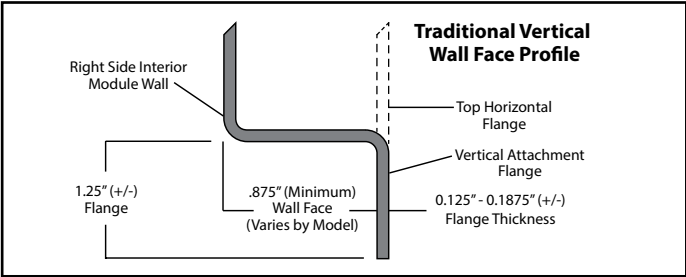
